The Victim Offender Dialogue Program (VOD) is a victim centered program designed to provide victims of violent crime the opportunity to participate in one face-to-face meeting with their offender in a safe and structured environment. This program is successful in several states and is an opportunity for the Commission to further assist victims and survivors of violent crimes. Offenders must be serving a parole eligible sentence in the state of Florida. Properly prepared offenders begin to grasp a more personal understanding of the extent of the impact of their crimes and of personal responsibility. Offenders may not use their participation in VOD to advance their parole or other post prison supervision.
