In 2015, the Town Council unanimously passed Resolution No. 15-1333 adopting the 2015-2025 Strategic Plan and authorizing the Town Manager to take all actions necessary to implement its policies and goals.

In 2003, a design consulting form completed the Town's Stormwater Master Plan in preparation for the Town assuming responsibility for stormwater management within its boundaries. The Town adopted Ordinance 03-31 which established the Town's Storm Water Utility and assumedmaintenance responsibility from Miami-Dade County for drainage facilities located within the Town boundary. In 2006, the Stormwater Master Plan Update #1 was completed.
