The Council recommended implementation of this project to improve both mobility and quality of life for residents, employees, and visitors within the Town and region. : A transportation improvements conceptual plan and a probable cost study were completed by an engineer consulting firm. A probable cost study was completed by an engineer consulting firm for the project. The opinion of probable cost for the project outlines \$242,000 for design and permitting; \$2.873 million for construction; \$150,000 for landscaping and irrigation; and \$483,000 for contingencies. Construction is estimated at 24 months. The project cost is approximated at \$5.8 Million
