Over time, the clay pipes have started to deteriorate and lift stations have become less efficient. Pipe lining would increase the structural integrity of the clay pipes and prevent the infiltration of groundwater into the main and lateral pipes. Once completed, this project is anticipated to have a useful life of approximately 50 years.
