Reduction of nutrient loading input to groundwater

Through the development, through-out the State, of the Springs Basin Management Action Plans (BMAP), the FDEP has established some data regarding the nutrient loading input to groundwater, from Onsite Sewage Treatment and Disposal Systems (OSTDS), commonly known as "septic tanks".

The data indicates OSTDS's input 4.5 kg-N/person/yr. (9.9 lbs-N/person/yr.) into the groundwater.
