11. What is the specific purpose or goal that will be achieved by the funds being requested?

The project consists making improvements to 7 locations that were identified as having the highest number of bicycle and pedestrian crashes between 2011 and 2015, and 1 of those locations is near a senior center (all on state roads). There have been 62 pedestrian crashes at these 7 locations over the last 4 years, 13 of which resulted in a fatality or incapacitating injury. The project will make improvements that could reduce ped crashes by 42-89%, according to Fed. Highway Administration.

Over the last year, the City has been working with Toole Design Group to update its Pedestrian and Bicycle Master Plan. The consultant began the plan update by studying the existing conditions in Jacksonville with respect to pedestrian and bicyclist safety. The results of the study showed that pedestrian crashes involving serious injuries and fatalities occur in all areas of the city. The most dangerous roads for pedestrians were found to be on state roadways.
