The City wishes to address water supply deficiencies by constructing a new 250 gpm well, a new SCADA system, and a new chlorination system. With the proposed improvements, the City will not only mitigate the current supply capacity shortfall, but also have sufficient capacity to carry the City as much as 20 years into the future. The project will supply water to 700 customers on the City's system. A new SCADA system will allow more capabilities and reliability than the antiquated current system.
