The county wants to build (with county funds) a 2.78 mile sidewalk but needs to make sure their efforts will not conflict with presently unknown stormwater needs, especially those needs that will cause portions of the sidewalk to be re-constructed or relocated. About 700 school aged children live in the area and the community currently has no sidewalks. Homes have septic tanks and drinking water comes from wells.
