This is a Hydrological restoration project that will re-hydrate and re-establish hydraulic connectivity between the Imperial River and its historic watershed to the east in the Corkscrew Swamp. This project will redirect flows from a stormwater ditch on the northern boundary of the property, south onto the property, and route it through two existing ponds and then into a dry river tributary. The project is estimated to reduce nitrogen loading in the Imperial River BMAP by 850 lbs/year.
