The Jupiter Inlet District proposes to restore an oxbow in the Wild and Scenic segment of the Loxahatchee River at RM 8.5 just downstream from Hobe Grove Ditch. The restoration will consist of filling what appears to be a man-made cut, clearly not visible in the 1940s aerials, and occurring over several decades. Depending on the results of engineering feasibility and hydrologic evaluation, the project may entail a minor reshaping of the oxbow to sustain increased water flows.
