During BNR construction improvements at the Sanford North WRF, Hurricane Matthew struck with excessive winds and 10 inches of rain that led to flows in excess of 16.5 MGD (capacity was 3.65 MGD). Equipment and infrastructure was damaged and a portion of the treatment process media was unintentionally discharged to the St. Johns River. Funding is being requested to pay for cleanup costs, equipment replacement, replacement of the media and clean-up of the discharge media in the St. Johns River.
