The purpose of this program is to provide home health care services to frail, home bound elderly individuals while they are assessed and referred to the Area Agency on Aging for enrollment into the Statewide Medicaid Managed Care Long-term Care program or other long-term care type service that assists in the delay of early institutionalization. FHANC estimates that it will provide one hour of service, three times per week to approximately 244 frail seniors for one year.
