Design & construction to replace, by force-account, the Center Hill Road Bridge, a one-lane 104 foot span timber bridge with a two-lane structure and the College Hill Road Bridge, a one-lane 86 foot span timber bridge with a two-lane structure. Both fail DOT standards, are "functionally obsolete", deemed hazardous, unsafe -- too narrow, lacks adequate clearance, or floods located in small fiscally constrained county.
