The City has 50 year old drinking water distribution piping infrastructure that has sever tuberculation. Tuberculation is the development of small mounds of corrosion products, caused by mineral deposits on the inside of the City's iron pipes. These mounds are reddish brown and various sizes. Tuberculation is detrimental to the City's pipes and has resulted in an increase pumping costs and a reduction in system pressure. Result is unacceptable non-revenue water loss chemical consumption.
