Restoration through silt, debris, vegetation removal, and possible stormwater infrastructure improvements would maximize the retention pond's ability to hold and control stormwater runoff, and thus minimizing the possibility of flooding. Refurbishing the Southway Villas drainage systems will improve greatly the water quality that is returned to the aquifer by removal of pollutants such as silt, chemicals, fertilizers, trash, and any other debris.
