In January, Jewish organizations across the country suffered 65 bomb threats that were phoned in to Jewish centers, including three threats that were phoned in to local Jewish preschools leading to evacuations of young children and teachers. These threats create fear as well as a loss of revenue for our communities. Our goal is to hire a security director who will lead the coordination of security efforts within the Tampa Bay region as well as communicate with security directors statewide.
