These funds are requested to expand passive recreation and conservation efforts in South Lee County, via the establishment of a regionally-significant natural asset. The village spent a significant amount of money to acquire this property (\$24.5 million) in early 2019, but the land does not have the amenities necessary to support public access or enjoyment, today, such as walking trails, a river walkway, or public restrooms. The requested funds will help gain the needed amenities/accessibility.

There is strong community support, backed up by public polling over the course of the last five years (some predating incorporation) that shows environmental protection is the top interest of Estero residents. It was, in fact, a primary driving force for Estero's incorporation (by a 86% vote) in late 2014. The Village Council voted unanimously (in front of an overflowing Council chamber of supporters) to purchase this \$24.5 million piece of land in late 2018 (300% of our operating budget).
