Representative Sands offered the following:

## Amendment (with directory and title amendments)

Between lines 15 and 16, insert:

(5) A presiding judge may, in his or her discretion, excuse a practicing attorney, a practicing physician, a practicing psychologist, or a person who is physically infirm from jury service, except that no person shall be excused from service on a civil trial jury solely on the basis that the person is deaf or hearing impaired, if that person wishes to serve, unless the presiding judge makes a finding that consideration of the evidence to be presented requires auditory discrimination or that the timely progression of the trial will be considerably affected thereby. However, nothing in this subsection shall affect a litigant's right to exercise a peremptory challenge.
