

1 A bill to be entitled
 2 An act relating to health insurance benefits for state
 3 employees; amending s. 110.123, F.S.; providing for
 4 the state's monthly contribution for employees under
 5 the state group insurance program; amending s.
 6 110.12315, F.S.; revising the conditions under which
 7 pharmacies are provided reimbursement for prescription
 8 medicines that are dispensed to members of the state
 9 group health insurance plan under the state employees'
 10 prescription drug program; authorizing the Department
 11 of Management Services to implement a supply limit
 12 program for certain maintenance drugs; reenacting
 13 provisions specifying copayment amounts for the state
 14 employees' prescription drug program; providing an
 15 effective date.

 17 Be It Enacted by the Legislature of the State of Florida:

 19 Section 1. Paragraph (a) of subsection (12) of section
 20 110.123, Florida Statutes, is amended to read:

21 110.123 State group insurance program.—

22 (12) HEALTH SAVINGS ACCOUNTS.—The department is authorized
 23 to establish health savings accounts for full-time and part-time
 24 state employees in association with a health insurance plan
 25 option authorized by the Legislature and conforming to the
 26 requirements and limitations of federal provisions relating to
 27 the Medicare Prescription Drug, Improvement, and Modernization
 28 Act of 2003.

29 (a)1. A member participating in this health insurance plan
 30 option is eligible to receive an employer contribution into the
 31 employee's health savings account from the State Employees
 32 Health Insurance Trust Fund in an amount to be determined by the
 33 Legislature. A member is not eligible for an employer
 34 contribution upon termination of employment. ~~For the 2011-2012~~
 35 ~~fiscal year,~~ The state's monthly contribution for employees
 36 having individual coverage shall be \$41.66 and the monthly
 37 contribution for employees having family coverage shall be
 38 \$83.33.

39 2. A member participating in this health insurance plan
 40 option is eligible to deposit the member's own funds into a
 41 health savings account.

42 Section 2. Paragraph (b) of subsection (2) of section
 43 110.12315, Florida Statutes, is amended, and, notwithstanding
 44 section 75 of chapter 2011-47, Laws of Florida, paragraph (a) of
 45 subsection (7) of that section, as reenacted by section 74 of
 46 chapter 2011-47, Laws of Florida, does not revert to the text of
 47 that paragraph in existence on December 31, 2010, and is
 48 reenacted and amended, to read:

49 110.12315 Prescription drug program.—The state employees'
 50 prescription drug program is established. This program shall be
 51 administered by the Department of Management Services, according
 52 to the terms and conditions of the plan as established by the
 53 relevant provisions of the annual General Appropriations Act and
 54 implementing legislation, subject to the following conditions:

55 (2) In providing for reimbursement of pharmacies for
 56 prescription medicines dispensed to members of the state group

57 health insurance plan and their dependents under the state
 58 employees' prescription drug program:

59 (b) There shall be a 30-day supply limit for prescription
 60 card purchases and 90-day supply limit for mail order or mail
 61 order prescription drug purchases. The Department of Management
 62 Services may implement a 90-day supply limit program for certain
 63 maintenance drugs as determined by the department at retail
 64 pharmacies participating in the program if the department
 65 determines it to be in the best financial interest of the state.

66 (7) Under the state employees' prescription drug program
 67 copayments must be made as follows:

68 (a) Effective January 1, 2012 ~~2011~~, for the State Group
 69 Health Insurance Standard Plan:

- 70 1. For generic drug with card \$7.
- 71 2. For preferred brand name drug with card \$30.
- 72 3. For nonpreferred brand name drug with card \$50.
- 73 4. For generic mail order drug \$14.
- 74 5. For preferred brand name mail order drug \$60.
- 75 6. For nonpreferred brand name mail order drug \$100.

76 Section 3. This act shall take effect July 1, 2012.
