### SUMMARY ANALYSIS

This reviser's bill replaces statutory reference to the "Division of Forestry" with references to the "Florida Forest Service" pursuant to the Legislative directive to the Division of Statutory Revision in s. 12, ch. 2011-56, Laws of Florida.

This reviser's bill amends provisions of the Florida Statutes by substituting "Florida Forest Service" for the term "Division of Forestry" where the term appears in the Florida Statutes pursuant to s. 12, ch. 2011-56, Laws of Florida.
