

# Components of the Formula

Variables in the formula (algorithm):

- Age—under 21 or 21 and over
- Living setting—family home, supported living, foster or group home, or residential habilitation center
- Questionnaire for Situational Information (QSI) needs assessment information:
  - Behavioral sum of scores
  - Functional sum of scores
- Answers to three individual questions on transfer, hygiene, and ability to self-protect

# Flexibility and Control in iBudget Florida

- Individuals can make changes to services within budget amount through the year to rapidly address changing needs.
- Unused funding can be shifted from past to future months to meet changing needs during a single fiscal year.
- Must be in crisis to get increased services—must demonstrate there are no other alternative sources of support.
- Critical health and safety services cannot be changed without APD approval.
- New automated systems improve controls and communications with individuals, waiver support coordinators, providers, and APD staff.





# Florida's Child Welfare System



# Community Based Care Lead Agencies



# Independent Living Program

- Prepares youth in foster care to be self-sufficient
- Provides services to adolescents in foster care ages 13 to 17
- Provides services and financial assistance to young adults formerly in foster care ages 18 to 23

# Program Outcomes

- Prior OPPAGA reports recommended that the department develop outcome measures for the program
- Measures are needed to assess whether the program is meeting its goals
- The department incorporated outcome measures for the program in CBC contracts in July 2010

## **Proposed Contract Measures**

- Percentage of youth who have aged out of care completing high school or GED by 20 years of age;
- Percentage of youth who completed high school or GED and are involved in post secondary education;
- Percentage of youth age 18 and over receiving Independent Living services who have a job (including joining the military);
- Percentage of young adults in safe housing; and
- Percentage of 17-year-old youth in licensed out of home care who had a transition plan signed by the youth and filed with the court.

# Current Status of Outcome Measures

- The department plans to have baseline data for contract measures by July 1, 2012
- A federal initiative requires states to implement the National Youth in Transition Database (NYTD) survey
- Data collection began in October 2010


# Tracking Services Provided to 13- to 17-year olds

- Prior OPPAGA reports recommended that the department track the number of 13- to 17-year old youth served by the program
- The department is currently collecting preliminary data through NYTD
- CBCs are entering data into the Florida Safe Families Network database

# Program Oversight

- The department
  - Established fiscal monitoring unit to review lead agency expenditures
  - Redesigned quality assurance system for child welfare
    - Special IL program reviews
  - Broadened the scope of contract monitoring

# Independent Living Services Advisory Council (ILSAC)

The council was created by the legislature with the “purpose of reviewing and making recommendations concerning the implementation and operation of the independent living transition services. . . Specifically, the advisory council shall assess the implementation and operation of the system of independent living transition services and advise the department on actions that would improve the ability of the independent living transition services to meet the established goals. The advisory council shall keep the department informed of problems being experienced with the services, barriers to the effective and efficient integration of services and support across systems, and successes that the system of independent living transition services has achieved. . . The advisory council shall report to the appropriate substantive committees of the Senate and House of Representatives on the status of the implementation of the system of independent living transition services.



# The Adolescent Brain

- ▶ New Research and its implications for young people transitioning from foster care.  
Jim Casey Youth Opportunities Initiative
  - ▶ “Young people’s experiences during this period play a critical role in shaping their futures as adults. They can build and practice resiliency and develop knowledge and skills that will positively serve them throughout adulthood.”

## Recommendations of the JCYOI Report

- 1. Take a positive youth development approach to all opportunities for youth in care.
- 2. Provide Interdependent living services that connect young people with family and caring adults.
- 3. Engage young people in their own planning and decision making.
- 4. Be trauma informed to promote healing and emotional security.
- 5. Extend developmentally appropriate foster care to age 21.

# Accountability


- ▶ Develop a program planning and delivery reporting tool for determining appropriate information regarding the independent living services, outcomes and fiscal implications on projected and actual delivery of services for all community based care lead agencies.

# Permanency


- Having a permanent “family” relationship and feeling connected to an adult who will be there for life are key to the well being of young people.
- Change the focus from “aging out” to permanency
- Change from the “system” providing independent living to quality parenting in the home.

# Life Skills

- Although independent living services produce some benefits by imparting knowledge and certain skills they have not been effective in supporting young people in building and sustaining social capital
- Experiential, practice, learn from mistakes
- Competency based
- Normalcy

# Youth Voice and Engagement

- Listen to youth
- Involve them in planning for their futures
- Nothing about us, without us
- Youth SHINE, Youth Advisory Councils, Youth Leadership Academy, Individual transition planning, and judicial reviews.



# Policy to Practice

- ▶ Every youth in care in Florida should have equal access to consistent quality practice and programs across the state.

# What they have told us

I have been in foster care for the last 16 years of my life and trust me this has been no smooth ride between losing your parents. That no easy thing for children to go through , it really hurts them. It makes the child feel that it is all their fault.

I don't like foster care, I don't want no help, all I want is to be with my family.

I have good foster parents and am proud to say I get good grades and most of the time am happy. The house is always clean and there is always food and if you do good in school you get extra allowance. Most important I feel love in my home.
