HEZEKIAH WILCOXSON



CLARA WHITE MISSION, JACKSONVILLE, FLORIDA

Hezekiah, a native of Havana, Florida, reared by both parents. Father was a retired veteran, he held a job in the mattress factory, but he was a functional alcoholic and mother was a house wife and very active in the church. He had two sisters, and two brothers. Hezekiah, was an average student in school and an athlete in Football, Track and a Boy Scout. Upon graduation, he joined the Army on October 8, 2005 and was discharged October 8, 2008. He was stationed at Fort Jackson and enjoyed the life of a family man and serving his country. He mentioned that being married and being in the military made him grounded and stable. Unfortunately, soon after he was discharged, his perfect family life was shattered by an unexpected death of his wife, whom he loved dearly. He found that coping and living without her was very challenging, which lead to a spiraling life of drugs. To soothe his pain, he began using "crack cocaine".

He moved to Tallahassee to run away and was in hopes of starting a new life. He acquired a new job as a electrical engineer and almost every day, he used drugs. He eventually, lost his job and started stealing to support his habit. He was arrested for the possession of drugs/ theft charges and served a year in prison. While in prison he was placed in a rehabilitation program to combat his addiction. After he completed his sentence and rehab program, he moved to Jacksonville, Florida for a fresh start again. He enrolled in the 20 week certified Culinary Arts Training/Transitional Housing Program at the Clara White Mission Training Center. He was drawn to the program, because he was advised that the program was designed to assist veterans, low-income and ex-offenders. After he was accepted for enrollment, he took advantage of the total program; he attended AA classes, life management classes, developed a positive support system and joined a local

church. He excelled and graduated with honors. He stated that the comprehensive program helped him find himself. He said, that while he was in prison, he had time to reflect on the positive choices of serving his country and being a family man, the negative encounters/choices he made in life, the death of his wife, the struggle of drug addiction, losing his job and just existing and being a nobody. He said that life at the mission reinforced the positive change that he was looking for in his new life.

Three days after graduation he was employed by Morning Star Foods, three months later he saved his money and moved into his own apartment. Three years clean, Mr. Wilcoxson has met his personal and career goals. He has found himself and got his life back.

Sylvester Black

Mr. Black had been in and out of prison for 27 years, before enrolling into Clara White Mission's Training Program. He was a resident at City Rescue Mission, until housing was available at Clara White Mission. Being released from prison was a BIG adjustment back into society. Unfortunately, upon being released he had no family support and know where to go. He had heard about the Clara White Mission Training Program through JREC. He was not interested in going back to the neighborhood that got him in trouble the first, second and third time. He had a plan, but need help! He was approved for the City Rescue Mission Program and then he enrolled in the Janitorial Training Program. He was definitely, seeking a new way of life. As he went through the 20 week program, Mr. Black began to evolve from a prison mindset to being excited about starting a new life with knowledge and skills. He often said, that he never finished anything in life but a prison sentence, but this time I am going to the finish line. Before graduation, he was very concerned about being able to qualify for employment, because of his lengthy criminal background. His aspiration and interest was not only to get a job, but to give back to youth in a meaningful way. He wanted to help keep them from leading a life of being in and out of prison like he did.

He was selected to share his testimony for the Clara White Mission Annual Fundraiser at the "Pearls and Cufflink" Gala. In the audience was Public Defender Matt Shirk. This was Mr. Shirk first time attending the event and was moved by Mr. Black story. After the Gala he requested Mr. Black, to come and complete an application at his office that following Monday. Mr. Black went to see the Public Defender and was prepared only to fill out an application, little

did he know, Mr. Shirk offered him a job, by noon Mr. Black had been hired as a part-time employee at the Public Defenders Office. He came back to the mission to show-off his new employee badge to staff, for entrance into the Public Defender's building.

Since 2009, Mr. Black has been a counselor and mentor for juveniles who have been processed into the system at least once. He mentors juveniles after school and keeps up with them at home and makes visits at school. Mr. Black has been with the Public Defender's office for two years as a part-time employee and recently was promoted to a full-time position. Currently, he has his own apartment and car.

1)Pamela Campbell

Ms. Campbell was born and grew up in Jacksonville, Florida. She graduated from Robert E Lee High School and went on to study nursing at Rice Institute. However, she encountered some major medical challenges and financial trials that lead her to become homeless. She has overcome those pitfalls and is now the owner of her own janitorial business. She is a graduate of the Janitorial/Environmental Service Class at Clara White Mission. She was recognized as Student of the Month while enrolled in the training program. Ms. Campbell has come to be the woman who is sure of herself and confident that she can be all she can be.

2) Mark Shoenberg

Mr. Schoenberg was born in Daytona Beach, Florida, his family moved to New York when he was still a toddler. He grew up there, graduated from high school, attended St. Johns College, and then served 6 years in the US Navy. The day after Christmas in 2009, he move back to Florida with the company he worked for and bought a house and a car. After three years, with the company, they laid him off. He couldn't find a job, he exhausted all of his savings, loss his house and car. With no money, Mr. Schoenberg became homeless. After a couple of months of being homeless, he obtained housing at Clara White Mission through the Veterans Transitional Housing Program. He enrolled in Janitorial/Environmental Class and graduated in July, 2010. Currently he is employed full time in the Janitorial Services Department at Mayo Clinic. Today, Mr. Shoenberg, has evolved into someone who now believes he can accomplish anything he sets out to do.

<u>3)JW</u>

In 2005 JW life started spiraling downhill. Her personal life of trying to keep her marriage and family together caused her to loss her successful cleaning business. By June of 2006, she became homeless. She had to apply for assistance from the State. In order to receive benefits, she was required to attend a class daily, if she didn't her benefits would be discontinued. She went to several agencies like Catholic Charities for help before she lost her home, but was told she could not be helped. Unfortunately, after owning a business, it looked like she had more than she did on paper. She volunteered and moved her family into Trinity Mission for Women and Children until she found a job at Publix making \$250 a week after taxes, which she worked for 11 months. In April, 2008, JW received a full-time job as a training instructor, the pay was better and there were benefits in many ways.

4) Carida Dora before coming to Jacksonville had a life, career, and family. She owned a successful Cuban Restaurant, which she enjoyed cooking and meeting people. She and her

husband had a rocky marriage. She accepted several years of physical and verbal abuse to keep the family together. Due to her commitment of being a wife and mother she endured the unhealthy situation. Carida was hoping their relationship would get better. She tried to make the marriage work, even suggested counseling. One day after working long hours, when she arrived home her husband and the children were gone and the house was empty. Her husband had abandoned her and left a note that he and their three children had moved to another state. She was devastated and called the police, but had no recourse.

After feeling sorry for herself, she was determined to get her life back. However, she needed some help. She was homeless with nowhere to go or stay. She became resourceful pretty quick and was able to reside at City Rescue Mission and Community Connection. She found out about the Clara White Mission Culinary Program. During her interview for the program, she shared her story with the staff. She mentions that she was very depressed and suffered from mental illness. After she was approved for the program the staff immediately coordinated services by contacting Sulzbacher to provide a mental health assessment and medication.

Carida, graduated the program with honors, Student of the Month, Academic Award and Chef Award. She is employed by a Nursing Home, as the Head Executive Chef.


