(b) Information made confidential and exempt under this subsection may be disclosed only:

- 1. To the injured employee or the dependents of the deceased employee;
- 2. In an aggregate reporting format that does not reveal the personal identifying information of any employee, if the aggregation includes the records of at least 10 employees and does not include records related to a date of accident occurring in the 90 days before a public records request;
- 3. To a party litigant, or his or her authorized representative, in matters pending before the Office of the Judges of Compensation Claims;
 - 4. Pursuant to a court order; or

- 5. To an administrative or law enforcement agency in the furtherance of such agency's official duties and responsibilities. An administrative or law enforcement agency receiving such information shall maintain the confidentiality of the information as provided in this section.
- (c) This subsection is subject to the Open Government

 Sunset Review Act in accordance with s. 119.15 and is repealed

 on October 2, 2022, unless reviewed and saved from repeal

 through reenactment by the Legislature.
- Section 2. The Legislature finds that it is a public necessity to make confidential and exempt from disclosure any information filed with the Department of Financial Services, the

Agency for Health Care Administration, or the Division of
Administrative Hearings pursuant to ch. 440, Florida Statutes,
that would identify an injured or deceased employee. Such
information is of a sensitive, personal nature. Disclosure of
such sensitive, personal information about an injured or
deceased employee is an invasion of the injured employee's
privacy or the privacy of the deceased employee's family.
Further, the release of such information could lead to
discrimination against the injured employee by coworkers,
potential employers, and others. The harm caused to an injured
employee or a deceased employee's family by the release of such
information outweighs any public benefit derived from its
release.

Section 3. This act shall take effect July 1, 2017.
