2018 STATE LEGISLATIVE PRIORITIES

HURRICANE IRMA

- State Support for FEMA reimbursement percentage and timeframe: State support/request for 90% or 100% reimbursement for Category A and B, and extended timeframes.
- 2. State Support for FEMA Advanced Payment/Immediate Needs Funding.
- 3. State Support for FEMA reimbursement for marine debris (canals and derelict vessels, \$28M.)
- State Support for FEMA Emergency Housing STEP program: State support/request for increased level of funding, extension of timeframes, household maximums, inclusion of workforce renters, enhanced scope to include full drywall.

MONROE COUNTY EMERGENCY OPERATION CENTER

- 1. Support funding for the design and construction of a Monroe County Emergency Operation Center. (\$20m)
 - Support funding from Florida Division of Emergency Management.
 - · Support legislative appropriation.

FLORIDA KEYS STEWARDSHIP ACT

- Water Quality: <u>Support \$20M appropriation</u> pursuant to The Florida Keys Stewardship Act (Chapter 2016-225, Laws of Florida) to construct water quality projects in the Florida Keys. (Local Commitment: \$7M in local funding expended, and commitment of \$20M in County RESTORE funding.)
- 2. Florida Forever: Support \$5M appropriation within Florida Forever for land acquisition within the Florida Keys as authorized in The Florida Keys Stewardship Act that will both retire development rights AND conserve environmentally sensitive land. (Local Commitment: \$16M in local funding committed.)
- 3. Enhanced land acquisition to address legal liability: <u>Support new statutory language to</u> enable the State to acquire land for the express purpose of reducing potential legal liability for private property rights claims that are anticipated to arise as a result of State imposed growth restriction due to the State's designation of the Florida Keys as an Area of Critical State Concern.

APPROPRIATIONS

- SUPPORT \$20M legislative appropriation for water quality projects in the Florida Keys, per FKSA.
- SUPPORT \$5M legislative appropriation for land acquisition in the Florida Keys through Florida Forever setaside, per FKSA
- SUPPORT funding from DEM, DOT, and Legislature for the construction of an Emergency Operation Center.
- SUPPORT \$500,000 legislative appropriation for pump-out services in the Florida Keys.
- SUPPORT \$7M legislative appropriation to DEP for Overseas Heritage Trail Pedestrian Bridges for the Preliminary Design and Engineering study to assess the conditions and repair options for Trail's bridges.
- SUPPORT \$8.5M in DOT SUNTrail Grant funding to DEP for Overseas Heritage Trail for construction of Sugarloaf section of Trail.
- SUPPORT legislative appropriations and/or agency funding for emergency costs related to Hurricane Irma.

Dear Representatives and Senators:

For many years now letter carriers have been at the forefront of community involvement. Whether reporting unusual vehicles in the neighborhoods we service daily, conducting the largest one day food drive in the world, watching after seniors with neighborhood watch programs, raising money through events held year round for the muscular dystrophy association, or coming to the aid of people in need, we are in the communities across America every day!

While credit is due to the police and fire departments as first responders, the presence of a mail delivery vehicle in a neighborhood is often the first sign of things returning to normal.

This year, after being ravaged by Hurricane Irma, letter carriers across the state of Florida began returning to work as soon as possible. In many cases, mail delivery was resumed before power had been restored. Letter carriers witnessed the widespread use of portable generators in neighborhood after neighborhood. When news reports began to come out of accidental carbon monoxide poisoning resulting in deaths in different parts of the state, the Florida State Association of Letter Carriers decided to get involved.

We would like to work with the state legislature to enact protection measures that address carbon monoxide poisoning. Such legislation could include the following:

- Mandating that a consumer purchasing a generator must also purchase a CO detector.
- Requiring that manufacturers of generators sold in Florida include a CO detector with the generator.
- Having the state of Florida issue a rebate in the form of a voucher upon receipt of proof of purchase of a CO detector along with a generator.
- Having the manufacturer of a generator issue a rebate in the form of a voucher upon receipt of proof of purchase of a CO detector along with a generator.

With the Speaker of the House establishing the Select Committee on Hurricane Response and Preparedness, we now have the perfect forum to bring attention to this issue. An issue which could affect the lives of many.

We are currently looking for a state representative and a senator to sponsor a bill that would accomplish our goal. We look forward to participating in this effort.
