

Dear Members of the Select Committee on Hurricane Response and Preparedness:

Please see the attached summary of proposals that have been shared with the committee to date. For each of the issue categories designated by Speaker Pro Temp Nuñez in her November 17th email to you, the summary first lists the issues and questions shared with you by the Speaker when the select committee was created, and then lists recommendations and suggestions shared with the select committee during its committee meetings or in writing. The summary document attempts to very briefly summarize the ideas presented to the select committee thus far, and is intended as a resource to assist you in developing your proposed recommendations.

Similar to the recommendations included in the summary document, your proposed recommendations need only summarize the proposal and do not need to provide background information, which can be provided at the meeting on Monday, December 4th. As a reminder, Speaker Pro Temp Nuñez asked that all recommendations be provided to staff by close of business on Thursday, November 30th. Staff will compile the submitted recommendations and provide the compiled list to all select committee members prior to the select committee's meeting on Monday, December 4th.
