Subject: Hurricane Response and Preparedness

Dear Members of the Select Committee on Hurricane Response and Preparedness:

As I explained at the end of today's select committee meeting, the next phase of our work together involves developing potential recommendations for the members to discuss at the select committee's Monday, December 4th meeting. I have grouped the many issues we have explored into several categories. To ensure that we cover all the issue areas, I am asking that you work with staff over the next two weeks to develop possible recommendations for the specific issue categories indicated below. You are free to contribute in other areas, and all select committee members will have an opportunity to participate in our discussions at our meeting on Monday, December 4th. To allow time for all members to review the possible recommendations you develop, I ask that all recommendations be provided to staff by close of business Thursday, November 30th. At our Monday, December 4th, meeting, the potential recommendations will be shared with the full committee for all members to discuss. The tentative plan is for the select committee to consider and vote on a set of recommendations at its Thursday, December 7th meeting.

The issue categories and member assignments are:

- Evacuation – Reps. Asencio , Grant, and Raschein
- Energy – Reps. Davis, Eagle, and Trumbull
- Shelters and Vulnerable Populations – Reps. Burgess, Byrd, and Shaw
- Health Care Facilities and Medical Care – Reps. Rodrigues, Sprowls, and Stark
- Agriculture – Reps. Albritton, Jacobs, and Porter
- Future Hurricane Expenditures and Tax Relief – Reps. Grant, Moskowitz, and Renner
- Housing – Reps. Cortes, Davis, and Raschein
- Beaches, Sanitary Sewers, Stormwater, Flooding, and Debris Removal – Reps. Eagle, Jacobs, and Stevenson
- Education – Reps. Asencio , Cortes, and Porter

Early next week, staff assigned to work with you will contact you and provide you with a summary of proposals that have been shared with the committee.
