- Offer students opportunities to pursue careers in both technical and academic fields.



# **Tuition Assistance Programs**

# William L. Boyd, IV, Effective Access to Student Education (EASE)

- Created in 1979 to provide tuition assistance to Florida residents enrolled in undergraduate degree programs at eligible independent colleges or universities in Florida.
- EASE is not related to a student's financial need or other criteria upon which financial aid programs are usually based.
- In the 2022-23 academic year, the EASE program distributed \$70,729,974 and served 41,189 full-time equivalent (FTE) students with a maximum annual award of \$2,000.
- The maximum annual award amount is established in the General Appropriations Act. The 2023-24 maximum award is \$3,500.

# **EASE Metrics Reporting**

- By September 1 of each year, postsecondary institutions receiving EASE funding must submit an EASE Grant Program Accountability Report to the Florida Department of Education, in a format prescribed by the department.
- The report must use the most recently available information on Florida resident students and include, at a minimum, the following performance metrics, by institution:
  - Access rate based upon percentage of Pell-eligible students.
  - Affordability rate based upon average student loan debt; federal, state, and institutional financial assistance; and average tuition and fees.
  - Graduation rate.
  - Retention rate.
  - Postgraduate employment or continuing education rate.
- The department shall recommend minimum performance standards that institutions must meet to remain eligible to receive EASE grants.

# 2023-24 Academic Year Updates

- Senate Bill 1272 created a postsecondary educational grant under the EASE grant program within section 1009.521, Florida Statutes.
- New Institutions:
  - Herzing University
  - South College
- New postsecondary institutions will be required to annually submit EASE Accountability Report data by September 1.
- Departures:
  - Miami International University of Art and Design
    - Permanently closed on September 30, 2023.
  - Johnson University
    - Final year of participation; closing at conclusion of fiscal year.
