22 Section 2. The Legislature finds that it is a public
23 necessity that My Safe Florida Home Program applications and
24 home inspection reports be made exempt from s. 119.07(1),
25 Florida Statutes, and s. 24(a), Article I of the State
26 Constitution. More than 99 percent of all home inspections and
27 grant applications are completed electronically or by phone.
28 Under current law, My Safe Florida Home Program applications and
29 home inspection reports are public records and can be obtained
30 by anyone for any purpose. These documents contain personal
31 information, including, but not limited to, names, e-mail
32 addresses, mailing addresses, and telephone numbers. This
33 information is unique to each individual and, when combined with
34 other personal identifying information, can be used for identity
35 theft, consumer scams, unwanted solicitations, or other invasive
36 contact. Additionally, the My Safe Florida Home Program
37 applications and home inspection reports contain detailed
38 descriptions and pictures of the inside and outside of
39 applicants' homes, including private areas, points of entry, and
