Section 1. Section 1003.41, Florida Statutes, is amended to read:

1003.41 Sunshine State Standards. --

(1) Public K-12 educational instruction in Florida is based on the "Sunshine State Standards." The State Board of Education shall review the Sunshine State Standards and replace them with the Next Generation Sunshine State Standards that establish the core content of the curricula to be taught in this state and that specify the core content knowledge and skills that K-12 public school students are expected to acquire. The Next Generation Sunshine State Standards must, at a minimum: 198529

- (a) Establish the core curricular content for language arts, science, mathematics, and social studies, as follows:
- 1. Language arts standards must establish specific curricular content for, at a minimum, the reading process, literary analysis, the writing process, writing applications, communication, and information and media literacy. The standards must include distinct grade-level expectations for the core content knowledge and skills that a student is expected to have acquired by each individual grade level from kindergarten through grade 8. The language arts standards for grades 9 through 12 may be organized by grade clusters of more than one grade level. The language arts standards must also identify significant literary genres and authors that encompass a comprehensive range of historical periods, from among which each school district shall select specific works of literature that a student is expected to read before high school graduation. The State Board of Education shall, in accordance with the expedited schedule established under subsection (2), review and replace the language arts standards adopted by the state board in 2007 with Next Generation Sunshine State Standards that comply with this subparagraph.
- 2. Science standards must establish specific curricular content for, at a minimum, the nature of science, earth and space science, physical science, and life science. The standards must include distinct grade-level expectations for the core content knowledge and skills that a student is expected to have acquired by each individual grade level from kindergarten

through grade 8. The science standards for grades 9 through 12 may be organized by grade clusters of more than one grade level.

- 3. Mathematics standards must establish specific curricular content for, at a minimum, algebra, geometry, probability, statistics, calculus, discrete mathematics, financial literacy, and trigonometry. The standards must include distinct grade-level expectations for the core content knowledge and skills that a student is expected to have acquired by each individual grade level from kindergarten through grade 8. The mathematics standards for grades 9 through 12 may be organized by grade clusters of more than one grade level.
- 4. Social studies standards must establish specific curricular content for, at a minimum, geography, United States and world history, government, civics, economics, and humanities. The standards must include distinct grade-level expectations for the core content knowledge and skills that a student is expected to have acquired by each individual grade level from kindergarten through grade 8. The social studies standards for grades 9 through 12 may be organized by grade clusters of more than one grade level.
- (b) Establish the core curricular content for visual and performing arts, physical education, health, and foreign languages. Standards for these subjects must establish specific curricular content and include distinct grade-level expectations for the core content knowledge and skills that a student is expected to have acquired by each individual grade level from kindergarten through grade 5. The standards for grades 6 through

- 12 may be organized by grade clusters of more than one grade level.
- (c) Identify the core curricular content that a student is expected to learn for each subject at each individual grade level in order to acquire the broad background knowledge needed for reading comprehension.
- (d) Be rigorous and relevant and provide for the logical, sequential progression of core curricular content that incrementally increases a student's core content knowledge and skills over time.
- (e) Integrate critical-thinking and problem-solving skills; communication, reading, and writing skills; mathematics skills; collaboration skills; contextual and applied-learning skills; technology-literacy skills; information and media-literacy skills; and civic-engagement skills.
- (f) Be organized according to a uniform structure and format that is consistent for each subject. The Next Generation Sunshine State Standards shall, for each subject and grade level, use the same alphanumeric coding system.
- (g) Be aligned to expectations for success in postsecondary education and high-skill, high-wage employment.
- (2) By December 31, 2008, the State Board of Education shall establish an expedited schedule for adoption of the Next Generation Sunshine State Standards and shall establish by rule a schedule for the periodic review and revision of the standards. The state board shall adopt the Next Generation Sunshine State Standards for each subject by December 31, 2011.

- (3) (a) The Commissioner of Education shall develop and submit to the State Board of Education proposed Next Generation Sunshine State Standards, and periodically submit proposed revisions to the standards, for adoption by the state board according to the schedules established under subsection (2). The commissioner, in developing the proposed standards, shall consult with renowned experts on K-12 curricular standards and content in each subject listed in paragraphs (1)(a) and (b) and shall consider standards that are implemented by other states or nations and regarded as exceptionally rigorous by the curricular and content experts. The commissioner may also consult with curricular and content experts in other subjects.
- (b) The commissioner shall submit the proposed standards for review and comment by Florida educators, school administrators, representatives of community colleges and state universities who have expertise in the content knowledge and skills necessary to prepare a student for postsecondary education, and leaders in business and industry. The commissioner, after considering any comments and making any revisions to the proposed standards, shall submit the standards for written evaluation by renowned experts on K-12 curricular standards and content.
- (c) The commissioner, upon finalizing the proposed standards, shall submit the standards and evaluations by the curricular and content experts to the Governor, the President of the Senate, and the Speaker of the House of Representatives at least 21 days before the State Board of Education considers adoption of the proposed standards.

- (4) The State Board of Education may adopt rules under ss. 120.536(1) and 120.54 to administer this section. These standards have been adopted by the State Board of Education and delineate the academic achievement of students, for which the state will hold schools accountable, in grades K-2, 3-5, 6-8, and 9-12 in the subjects of language arts, mathematics, science, social studies, the arts, health and physical education, and foreign languages. They include standards in reading, writing, history, government, geography, economics, and computer literacy.
- Section 2. Paragraph (i) of subsection (9) of section 220.187, Florida Statutes, is amended to read:
- 220.187 Credits for contributions to nonprofit scholarship-funding organizations.--
- (9) DEPARTMENT OF EDUCATION OBLIGATIONS.--The Department of Education shall:
- (i) In accordance with State Board of Education rule, identify and select the nationally norm-referenced tests, and that are comparable to the norm referenced provisions of the Florida Comprehensive Assessment Test (FCAT) provided that the FCAT may be one of the tests selected. However, the Department of Education may approve schools to the use of an additional assessments, which meet assessment by the school if the assessment meets industry standards of quality and comparability.
- Section 3. Subsection (7) of section 1000.21, Florida Statutes, is amended to read:

1000.21 Systemwide definitions.--As used in the Florida K-20 Education Code:

- Sunshine State Standards" or the "Next Generation Sunshine State Standards" means the state's public K-12 curricular are standards adopted under s. 1003.41. The term includes the Sunshine State Standards that are in place for a subject until the standards for that subject are replaced under s. 1003.41 by the Next Generation Sunshine State Standards. that identify what public school students should know and be able to do. These standards delineate the academic achievement of students for which the state will hold its public schools accountable in grades K 2, 3 5, 6 8, and 9 12, in the subjects of language arts, mathematics, science, social studies, the arts, health and physical education, foreign languages, reading, writing, history, government, geography, economics, and computer literacy.
- Section 4. Subsection (1) of section 1001.03, Florida Statutes, is amended to read:
 - 1001.03 Specific powers of State Board of Education. --
- (1) PUBLIC K-12 <u>CURRICULAR</u> STUDENT PERFORMANCE
 STANDARDS.--The State Board of Education shall <u>adopt and</u>
 periodically review and revise approve the student performance
 standards known as the Sunshine State Standards in <u>accordance</u>

A report including proposed revisions must be submitted to the Governor, the President of the Senate, and the Speaker of the House of Representatives annually to coincide with the established review schedule. The review schedule and an annual status report must be submitted to the Governor, the President of the Senate, and the Speaker of the House of Representatives annually not later than January 1.

Standards. The standards and policies must emphasize integration and reinforcement of reading, writing, and mathematics skills across all subjects, including career awareness, career exploration, and Career and technical education standards and policies must integrate with and reinforce the Next Generation Sunshine State Standards.

Section 6. Paragraph (a) of subsection (1) of section 1001.452, Florida Statutes, is amended to read:

1001.452 District and school advisory councils.--

- (1) ESTABLISHMENT. --
- The district school board shall establish an advisory (a) council for each school in the district and shall develop procedures for the election and appointment of advisory council members. Each school advisory council shall include in its name the words "school advisory council." The school advisory council shall be the sole body responsible for final decisionmaking at the school relating to implementation of the provisions of ss. 1001.42(16) and 1008.345. A majority of the members of each school advisory council must be persons who are not employed by the school district. Each advisory council shall be composed of the principal and an appropriately balanced number of teachers, education support employees, students, parents, and other business and community citizens who are representative of the ethnic, racial, and economic community served by the school. Career center and high school advisory councils shall include students, and middle and junior high school advisory councils may include students. School advisory councils of career centers and adult education centers are not required to include parents 198529

as members. Council members representing teachers, education support employees, students, and parents shall be elected by their respective peer groups at the school in a fair and equitable manner as follows:

- 1. Teachers shall be elected by teachers.
- 2. Education support employees shall be elected by education support employees.
 - 3. Students shall be elected by students.
 - 4. Parents shall be elected by parents.

The district school board shall establish procedures for use by schools in selecting business and community members that include means of ensuring wide notice of vacancies and of taking input on possible members from local business, chambers of commerce, community and civic organizations and groups, and the public at large. The district school board shall review the membership composition of each advisory council. If the district school board determines that the membership elected by the school is not representative of the ethnic, racial, and economic community served by the school, the district school board shall appoint additional members to achieve proper representation. The commissioner shall determine if schools have maximized their efforts to include on their advisory councils minority persons and persons of lower socioeconomic status. Although schools are strongly encouraged to establish school advisory councils, the district school board of any school district that has a student population of 10,000 or fewer may establish a district advisory council which shall include at least one duly elected teacher 198529

from each school in the district. For the purposes of school advisory councils and district advisory councils, the term "teacher" shall include classroom teachers, certified student services personnel, and media specialists. For purposes of this paragraph, "education support employee" means any person employed by a school who is not defined as instructional or administrative personnel pursuant to s. 1012.01 and whose duties require 20 or more hours in each normal working week.

Section 7. Paragraph (i) of subsection (3) of section 1003.413, Florida Statutes, is amended to read:

1003.413 Florida Secondary School Redesign Act. --

- (3) Based on these guiding principles, district school boards shall establish policies to implement the requirements of ss. 1003.4156, 1003.428, and 1003.493. The policies must address:
- (i) An annual review of each high school student's electronic personal education plan created pursuant to s.

 1003.4156 and procedures for high school students who have not prepared an electronic personal education plan pursuant to s.

 1003.4156 to prepare such plan.
- Section 8. Paragraph (a) of subsection (2), paragraph (b) of subsection (4), and paragraph (a) of subsection (8) of section 1003.428, Florida Statutes, are amended to read:
- 1003.428 General requirements for high school graduation; revised.--
- (2) The 24 credits may be earned through applied, integrated, and combined courses approved by the Department of Education and shall be distributed as follows:

- (a) Sixteen core curriculum credits:
- 1. Four credits in English, with major concentration in composition, reading for information, and literature.
- 2. Four credits in mathematics, one of which must be Algebra I, a series of courses equivalent to Algebra I, or a higher-level mathematics course. School districts are encouraged to set specific goals to increase enrollments in, and successful completion of, geometry and Algebra II.
- 3. Three credits in science, two of which must have a laboratory component.
- 4. Three credits in social studies as follows: one credit in American history; one credit in world history; one-half credit in economics; and one-half credit in American government.
- 5. One credit in fine or performing arts, which may include speech and debate or practical arts.
- 6. One credit in physical education to include integration of health. Participation in an interscholastic sport at the junior varsity or varsity level for two full seasons shall satisfy the one-credit requirement in physical education if the student passes a competency test on personal fitness with a score of "C" or better. The competency test on personal fitness must be developed by the Department of Education. A district school board may not require that the one credit in physical education be taken during the 9th grade year. Completion of one semester with a grade of "C" or better in a marching band class, in a physical activity class that requires participation in marching band activities as an extracurricular activity, or in a dance class shall satisfy one-half credit in physical education 198529

or one-half credit in performing arts. This credit may not be used to satisfy the personal fitness requirement or the requirement for adaptive physical education under an individual education plan (IEP) or 504 plan. Completion of 2 years in a Reserve Officer Training Corps (R.O.T.C.) class, a significant component of which is drills, shall satisfy the one-credit requirement in physical education and the one-credit requirement in performing arts. This credit may not be used to satisfy the personal fitness requirement or the requirement for adaptive physical education under an individual education plan (IEP) or 504 plan.

- (4) Each district school board shall establish standards for graduation from its schools, which must include:
- (b) Earning passing scores on the FCAT, as defined in s. 1008.22(3)(c), or scores on a standardized test that are concordant with passing scores on the FCAT as defined in <u>s.</u> 1008.22(10) <u>s. 1008.22(9)</u>.

Each district school board shall adopt policies designed to assist students in meeting the requirements of this subsection. These policies may include, but are not limited to: forgiveness policies, summer school or before or after school attendance, special counseling, volunteers or peer tutors, school-sponsored help sessions, homework hotlines, and study skills classes. Forgiveness policies for required courses shall be limited to replacing a grade of "D" or "F," or the equivalent of a grade of "D" or "F," with a grade of "C" or higher, or the equivalent of a grade of "C" or higher, earned subsequently in the same or 198529

Section 13. Subsection (1) of section 1003.433, Florida Statutes, is amended to read:

1003.433 Learning opportunities for out-of-state and out-of-country transfer students and students needing additional instruction to meet high school graduation requirements.--

(1) Students who enter a Florida public school at the eleventh or twelfth grade from out of state or from a foreign country shall not be required to spend additional time in a Florida public school in order to meet the high school course requirements if the student has met all requirements of the school district, state, or country from which he or she is transferring. Such students who are not proficient in English should receive immediate and intensive instruction in English language acquisition. However, to receive a standard high school diploma, a transfer student must earn a 2.0 grade point average 198529

and pass the grade 10 FCAT required in s. 1008.22(3) or an alternate assessment as described in s. 1008.22(10) s. 1008.22(9).

Section 14. Paragraph (d) of subsection (6) of section 1003.63, Florida Statutes, is amended to read:

1003.63 Deregulated public schools pilot program. --

- (6) ELEMENTS OF THE PROPOSAL.--The major issues involving the operation of a deregulated public school shall be considered in advance and written into the proposal.

A student who has completed or who is exempt from the college-level communication and computation skills examination pursuant to s. 1008.29, or who is exempt from the college entry-level examination pursuant to s. 1008.29, is exempt from the provisions of this section. (c) The common placement test authorized in ss. 1001.03(10) and 1008.30 or a similar test may be administered to all high school students second semester sophomores who have chosen one of the four destinations. The results of the placement test shall be used to target additional instructional needs in reading, writing, and mathematics prior to graduation.

Section 19. Section 1007.212, Florida Statutes, is created to read:

1007.212 Remediation Reform Pilot Project.--

(1) The Legislature finds that the cost to the state and to students for remedial education has exceeded \$100 million in 198529

- recent years. The Legislature further finds that it is in the public's best interest to identify policies and best practices that reduce the need for and the cost of remediation for recent high school graduates who enter postsecondary education.
- (2) Beginning with the 2008-2009 school year, there is created the Remediation Reform Pilot Project with the goal of reducing the need for and the cost of remediation for recent high school graduates who enter postsecondary education.
- (3) The Department of Education shall develop by August 1, 2008, an application process for community colleges and school districts to participate in the pilot project. Each application must represent a collaborative effort between one or more community colleges and one or more school districts in each community college's service area.
 - (4) Each application shall:
- (a) Identify the specific area or areas of remediation to be addressed as part of the pilot project.
- (b) Provide the most recent data available from the postsecondary feedback reports produced pursuant to s. 1008.37 for each community college and school district that will participate in the pilot project for the area or areas of remediation that will be addressed during the course of the project.
- (c) Describe the strategies currently used by the participating institutions to address remediation needs, including mechanisms used to identify students who need remediation, corrective actions employed to address identified

- needs, and methods used to evaluate the effectiveness of these strategies.
- (d) Describe any proposed changes to current strategies that have been designed to reduce the need for postsecondary remediation, including, but not limited to:
- 1. Specific intervention efforts that will be employed to address identified deficiencies.
- 2. The process the community college and the school district will use to determine the effectiveness of the changes.
 - 3. A projected timeline for implementation of the changes.
- (e) Describe specific professional development activities that will be provided for secondary education faculty.
- (f) Provide itemized estimates of the costs to each participating community college and school district of implementing the proposal.
- (g) Identify any local, federal, or private funding that may be available to support the project.
- (h) Project any reductions in the need for and the cost of remediation that are anticipated following implementation and describe the method used to develop the projections.
- (5) By October 1, 2008, the Commissioner of Education shall evaluate the applications and recommend no more than four proposals to the President of the Senate and the Speaker of the House of Representatives for consideration and final approval. To the extent possible, the proposals recommended by the commissioner shall be representative of the geographic regions of the state and representative of large, medium, and small school districts.

- (6) Each community college and school district
 participating in the pilot project shall submit an annual status
 report, including a description of the strategies implemented,
 any costs incurred, and the effectiveness of the strategies used
 in reducing the need for and the cost of postsecondary
 remediation to students and the state. This report shall be
 submitted to the Executive Office of the Governor, the President
 of the Senate, the Speaker of the House of Representatives, the
 Commissioner of Education, and the Office of Program Policy
 Analysis and Government Accountability by September 1. The
 Office of Program Policy Analysis and Government Accountability
 shall analyze the reports submitted pursuant to this subsection
 to identify the policies and practices that are most effective
 in reducing the need for and the cost of remediation, including
 any cost savings realized as a result of implementation.
- (7) The pilot project shall be funded as provided in the General Appropriations Act. The Department of Education, school districts, and community colleges may redirect existing resources for purposes of the pilot project and are encouraged to seek and accept grants from additional public and private sources to implement the pilot project.

- (b) 1. A delineation of courses and programs available to students eligible to participate in dual enrollment. This delineation must include a plan for the community college to provide guidance services to participating students on the selection of courses in the dual enrollment program. The process of community college guidance should make maximum use of the automated advisement system for community colleges. The plan must assure that each dual enrollment student is encouraged to identify a postsecondary education objective with which to quide the course selection. At a minimum, each student's plan should include a list of courses that will result in an Applied Technology Diploma, an Associate in Science degree, or an Associate in Arts degree. If the student identifies a baccalaureate degree as the objective, the plan must include courses that will meet the general education requirements and any prerequisite requirements for entrance into a selected baccalaureate degree program.
- 2. A delineation of the process by which students and their parents are informed about opportunities to participate in articulated acceleration programs.
- 3. A delineation of the process by which students and their parents exercise their option to participate in an articulated acceleration program.
- 4. A delineation of high school credits earned for completion of each dual enrollment course.

- 5. Provision for postsecondary courses that meet the criteria for inclusion in a district articulated acceleration program to be counted toward meeting the graduation requirements of s. 1003.43.
- 6. An identification of eligibility criteria for student participation in dual enrollment courses and programs.
- 7. A delineation of institutional responsibilities regarding student screening prior to enrollment and monitoring student performance subsequent to enrollment in dual enrollment courses and programs.
- 8. An identification of the criteria by which the quality of dual enrollment courses and programs are to be judged and a delineation of institutional responsibilities for the maintenance of instructional quality.
- 9. A delineation of institutional responsibilities for assuming the cost of dual enrollment courses and programs that includes such responsibilities for student instructional materials.
- 10. An identification of responsibility for providing student transportation if the dual enrollment instruction is conducted at a facility other than the high school campus.
- 11. A delineation of the process for converting college credit hours earned through dual enrollment and early admission programs to high school credit based on mastery of course outcomes as determined by the Department of Education in accordance with s. 1007.271(6).
- 12. An identification of the responsibility of the postsecondary educational institution for assigning letter 198529

grades for dual enrollment courses and the responsibility of school districts for posting dual enrollment course grades to the high school transcript as assigned by the postsecondary institution awarding the credit.

Section 21. Subsection (16) of section 1007.271, Florida Statutes, is amended to read:

1007.271 Dual enrollment programs. --

(16) Beginning with students entering grade 9 in the 2006-2007 school year, school districts and community colleges must weigh dual enrollment courses the same as advanced placement, International Baccalaureate, and Advanced International Certificate of Education courses when grade point averages are calculated. Alternative grade calculation or weighting systems that discriminate against dual enrollment courses are prohibited. Beginning with students applying for admission to a state university for the 2009-2010 academic year, state universities must weigh dual enrollment courses the same as comparable Advanced Placement, International Baccalaureate, and Advanced International Certificate of Education courses when calculating grade point averages for purposes of making admissions decisions.

Section 22. Section 1008.22, Florida Statutes, is amended to read:

1008.22 Student assessment program for public schools.--

(1) PURPOSE.--The primary purposes of the student assessment program are to provide information needed to improve the public schools by enhancing the learning gains of all

students and to inform parents of the educational progress of their public school children. The program must be designed to:

- (a) Assess the annual learning gains of each student toward achieving the Sunshine State Standards appropriate for the student's grade level.
- (b) Provide data for making decisions regarding school accountability and recognition.
- (c) Identify the educational strengths and needs of students and the readiness of students to be promoted to the next grade level or to graduate from high school with a standard or special high school diploma.
- (d) Assess how well educational goals and <u>curricular</u> performance standards are met at the school, district, and state levels.
- (e) Provide information to aid in the evaluation and development of educational programs and policies.
- (f) Provide information on the performance of Florida students compared with that of other students across the United States.
- (2) NATIONAL EDUCATION COMPARISONS.--It is Florida's intent to participate in the measurement of national educational goals. The Commissioner of Education shall direct Florida school districts to participate in the administration of the National Assessment of Educational Progress, or a similar national assessment program, both for the national sample and for any state-by-state comparison programs which may be initiated. The Such assessments must be conducted using the data collection procedures, the student surveys, the educator surveys, and other 198529

instruments included in the National Assessment of Educational Progress or similar program being administered in Florida. The results of these assessments shall be included in the annual report of the Commissioner of Education specified in this section. The administration of the National Assessment of Educational Progress or similar program shall be in addition to and separate from the administration of the statewide assessment program.

- STATEWIDE ASSESSMENT PROGRAM. -- The commissioner shall (3) design and implement a statewide program of educational assessment that provides information for the improvement of the operation and management of the public schools, including schools operating for the purpose of providing educational services to youth in Department of Juvenile Justice programs. The commissioner may enter into contracts for the continued administration of the assessment, testing, and evaluation programs authorized and funded by the Legislature. Contracts may be initiated in 1 fiscal year and continue into the next and may be paid from the appropriations of either or both fiscal years. The commissioner is authorized to negotiate for the sale or lease of tests, scoring protocols, test scoring services, and related materials developed pursuant to law. Pursuant to the statewide assessment program, the commissioner shall:
- (a) Submit proposed Next Generation Sunshine State

 Standards to the State Board of Education for adoption and periodic review and revision under s. 1003.41 a list that specifies student skills and competencies to which the goals for education specified in the state plan apply, including, but not 198529

limited to, reading, writing, science, and mathematics. The skills and competencies must include problem-solving and higher-order skills as appropriate and shall be known as the Sunshine State Standards as defined in s. 1000.21. The commissioner shall select such skills and competencies after receiving recommendations from educators, citizens, and members of the business community. The commissioner shall submit to the State Board of Education revisions to the list of student skills and competencies in order to maintain continuous progress toward improvements in student proficiency.

- (b) Develop and implement a uniform system of indicators to describe the performance of public school students and the characteristics of the public school districts and the public schools. These indicators must include, without limitation, information gathered by the comprehensive management information system created pursuant to s. 1008.385 and student achievement information obtained pursuant to this section.
- (c) Develop and implement a student achievement testing program known as the Florida Comprehensive Assessment Test (FCAT) as part of the statewide assessment program to measure a student's content knowledge and skills in reading, writing, science, and mathematics. Other content areas may be included as directed by the commissioner. Comprehensive assessments The assessment of reading and mathematics shall be administered annually in grades 3 through 10. Comprehensive assessments The assessment of writing and science shall be administered at least once at the elementary, middle, and high school levels. End-of-course assessments for a subject may be administered in addition 198529

877 to the comprehensive assessments required for that subject under 878 this paragraph. An end-of-course assessment must be rigorous, standardized, approved by the department, and administered 879 880 districtwide in any school district that administers the 881 assessment. The content knowledge and skills assessed by 882 comprehensive and end-of-course assessments must be aligned to 883 the core curricular content established in the Sunshine State 884 Standards. The commissioner may select one or more nationally 885 developed comprehensive examinations, which may include, but need not be limited to, examinations for a College Board 886 887 Advanced Placement course, International Baccalaureate course, 888 or Advanced International Certificate of Education course or 889 industry-approved examinations to earn national industry certifications as defined in s. 1003.492, for use as end-of-890 course assessments under this paragraph, if the commissioner 891 determines that the content knowledge and skills assessed by the 892 examinations meet or exceed the grade-level expectations for the 893 894 core curricular content established for the course in the Next 895 Generation Sunshine State Standards. The commissioner may 896 collaborate with the American Diploma Project in the adoption or 897 development of rigorous end-of-course assessments that are 898 aligned to the Next Generation Sunshine State Standards The 899 commissioner must document the procedures used to ensure that 900 the versions of the FCAT which are taken by students retaking 901 the grade 10 FCAT are equally as challenging and difficult as the tests taken by students in grade 10 which contain 902 903 performance tasks. The testing program must be designed as 904 follows so that:

198529

- 1. The tests <u>shall</u> measure student skills and competencies adopted by the State Board of Education as specified in paragraph (a). The tests must measure and report student proficiency levels of all students assessed in reading, writing, mathematics, and science. The commissioner shall provide for the tests to be developed or obtained, as appropriate, through contracts and project agreements with private vendors, public vendors, public agencies, postsecondary educational institutions, or school districts. The commissioner shall obtain input with respect to the design and implementation of the testing program from state educators, assistive technology experts, and the public.
- 2. The testing program shall be composed will include a combination of norm referenced and criterion-referenced tests that shall and include, to the extent determined by the commissioner, include test items questions that require the student to produce information or perform tasks in such a way that the core content knowledge and skills and competencies he or she uses can be measured.
- 3. Beginning with the 2008-2009 school year, the commissioner shall discontinue administration of the selected-response test items on the comprehensive assessments of writing.

 Beginning with the 2012-2013 school year, the comprehensive assessments of writing shall be composed of a combination of selected-response test items, short-response performance tasks, and extended-response performance tasks, which shall measure a student's content knowledge of writing, including, but not limited to, paragraph and sentence structure, sentence 198529

construction, grammar and usage, punctuation, capitalization, spelling, parts of speech, verb tense, irregular verbs, subject-verb agreement, and noun-pronoun agreement. Each testing program, whether at the elementary, middle, or high school level, includes a test of writing in which students are required to produce writings that are then scored by appropriate and timely methods.

- 4. A score <u>shall be</u> <u>is</u> designated for each subject area tested, below which score a student's performance is deemed inadequate. The school districts shall provide appropriate remedial instruction to students who score below these levels.
- 5. Except as provided in s. 1003.428(8)(b) or s. 1003.43(11)(b), students must earn a passing score on the grade 10 assessment test described in this paragraph or attain concordant scores as described in subsection (9) in reading, writing, and mathematics to qualify for a standard high school diploma. The State Board of Education shall designate a passing score for each part of the grade 10 assessment test. In establishing passing scores, the state board shall consider any possible negative impact of the test on minority students. The State Board of Education shall adopt rules which specify the passing scores for the grade 10 FCAT. Any such rules, which have the effect of raising the required passing scores, shall only apply only to students taking the grade 10 FCAT for the first time after such rules are adopted by the State Board of Education.
- 6. Participation in the testing program is mandatory for all students attending public school, including students served 198529

in Department of Juvenile Justice programs, except as otherwise prescribed by the commissioner. If a student does not participate in the statewide assessment, the district must notify the student's parent and provide the parent with information regarding the implications of such nonparticipation. A parent must provide signed consent for a student to receive classroom instructional accommodations that would not be available or permitted on the statewide assessments and must acknowledge in writing that he or she understands the implications of such instructional accommodations. The State Board of Education shall adopt rules, based upon recommendations of the commissioner, for the provision of test accommodations for students in exceptional education programs and for students who have limited English proficiency. Accommodations that negate the validity of a statewide assessment are not allowable in the administration of the FCAT. However, instructional accommodations are allowable in the classroom if included in a student's individual education plan. Students using instructional accommodations in the classroom that are not allowable as accommodations on the FCAT may have the FCAT requirement waived pursuant to the requirements of s. 1003.428(8)(b) or s. 1003.43(11)(b).

- 7. A student seeking an adult high school diploma must meet the same testing requirements that a regular high school student must meet.
- 8. District school boards must provide instruction to prepare students to demonstrate proficiency in the <u>core</u>

 <u>curricular content established in the Next Generation Sunshine</u>

 198529

State Standards adopted under s. 1003.41, including the core content knowledge and skills and competencies necessary for successful grade-to-grade progression and high school graduation. If a student is provided with instructional accommodations in the classroom that are not allowable as accommodations in the statewide assessment program, as described in the test manuals, the district must inform the parent in writing and must provide the parent with information regarding the impact on the student's ability to meet expected proficiency levels in reading, writing, and mathematics math. The commissioner shall conduct studies as necessary to verify that the required core curricular content is skills and competencies are part of the district instructional programs.

- 9. District school boards must provide opportunities for students to demonstrate an acceptable level of performance on an alternative standardized assessment approved by the State Board of Education following enrollment in summer academies.
- 10. The Department of Education must develop, or select, and implement a common battery of assessment tools that will be used in all juvenile justice programs in the state. These tools must accurately measure the <u>core curricular content</u> skills and <u>competencies</u> established in the Sunshine State Standards.
- 11. For students seeking a special diploma pursuant to s. 1003.438, the Department of Education must develop or select and implement an alternate assessment tool that accurately measures the core curricular content skills and competencies established in the Sunshine State Standards for students with disabilities under s. 1003.438.

- 12. The Commissioner of Education shall establish schedules for the administration of statewide assessments and the reporting of student test results. The commissioner shall, by August 1 of each year, notify each school district in writing and publish on the department's Internet website the testing and reporting schedules for, at a minimum, the school year following the upcoming school year. The testing and reporting schedules shall require that:
- a. There is the latest possible administration of statewide assessments and the earliest possible reporting to the school districts of student test results which is feasible within available technology and specific appropriations; however, test results must be made available no later than the final day of the regular school year for students.
- b. Beginning with the 2010-2011 school year, a comprehensive statewide assessment of writing is not administered earlier than the week of March 1 and a comprehensive statewide assessment of any other subject is not administered earlier than the week of April 15.
- c. The department-approved end-of-course assessment is administered within the last 2 weeks of the course.

The commissioner may, based on collaboration and input from school districts, design and implement student testing programs, for any grade level and subject area, necessary to effectively monitor educational achievement in the state, including the measurement of educational achievement of the Sunshine State Standards for students with disabilities. Development and 198529

refinement of assessments shall include universal design principles and accessibility standards that will prevent any unintended obstacles for students with disabilities while ensuring the validity and reliability of the test. These principles should be applicable to all technology platforms and assistive devices available for the assessments. The field testing process and psychometric analyses for the statewide assessment program must include an appropriate percentage of students with disabilities and an evaluation or determination of the effect of test items on such students.

- (d) Conduct ongoing research to develop improved methods of assessing student performance, including, without limitation, the use of technology to administer tests, score, or report the results of, the use of electronic transfer of data, the development of work-product assessments, and the development of process assessments.
- (e) Conduct ongoing research and analysis of student achievement data, including, without limitation, monitoring trends in student achievement by grade level and overall student achievement, identifying school programs that are successful, and analyzing correlates of school achievement.
- (f) Provide technical assistance to school districts in the implementation of state and district testing programs and the use of the data produced pursuant to such programs.
- (g) Study the cost and student achievement impact of secondary end-of-course assessments, including web-based and performance formats, and report to the Legislature prior to implementation.

- (4) STATEWIDE ASSESSMENT PREPARATION; PROHIBITED

 ACTIVITIES.--Beginning with the 2008-2009 school year, a

 district school board shall prohibit each public school from

 suspending a regular program of curricula for purposes of

 administering practice tests or engaging in other test
 preparation activities for a statewide assessment. However, a

 district school board may authorize a public school to engage in

 the following test-preparation activities for a statewide

 assessment:
- (a) Distributing to students the sample test books and answer keys published by the Department of Education.
- (b) Providing individualized instruction in test-taking strategies, without suspending the school's regular program of curricula, for a student who scores at Level 1 or Level 2 on a prior administration of the statewide assessment.
- (c) Providing individualized instruction in the content knowledge and skills assessed, without suspending the school's regular program of curricula, for a student who scores at Level 1 or Level 2 on a prior administration of the statewide assessment or a student who, through a diagnostic assessment administered by the school district, is identified as having a deficiency in the content knowledge and skills assessed.
- (d) Incorporating test-taking exercises and strategies into curricula for intensive reading and mathematics intervention courses.
- (e) Administering a practice test or engaging in other test-preparation activities for the statewide assessment which are determined necessary to familiarize students with the 198529

organization of the assessment, the format of the test items, and the test directions, or which are otherwise necessary for the valid and reliable administration of the assessment, as set forth in rules adopted by the State Board of Education with specific reference to this paragraph.

board shall periodically assess student performance and achievement within each school of the district. The assessment programs must be based on the core curricular content established in the Next Generation Sunshine State Standards and any upon local goals and objectives that are compatible with the state plan for education and that supplement the core content knowledge and skills necessary for successful grade-to-grade progression and high school graduation and competencies adopted by the State Board of Education. All school districts must participate in the statewide assessment program designed to measure annual student learning and school performance. All district school boards shall report assessment results as required by the state management information system.

(6)(5) SCHOOL TESTING PROGRAMS.--Each public school shall participate in the statewide assessment program in accordance with the testing and reporting schedules published by the Commissioner of Education under subparagraph (3)(c)12.7 unless specifically exempted by state board rule based on serving a specialized population for which standardized testing is not appropriate. Student performance data shall be analyzed and reported to parents, the community, and the state. Student performance data shall be used in developing objectives of the 198529

school improvement plan, evaluation of instructional personnel, evaluation of administrative personnel, assignment of staff, allocation of resources, acquisition of instructional materials and technology, performance-based budgeting, and promotion and assignment of students into educational programs. The analysis of student performance data also must identify strengths and needs in the educational program and trends over time. The analysis must be used in conjunction with the budgetary planning processes developed pursuant to s. 1008.385 and the development of the programs of remediation.

- (7) (6) REQUIRED ANALYSES.--The commissioner shall provide, at a minimum, for the following analyses of data produced by the student achievement testing program:
- (a) The statistical system for the annual assessments shall use measures of student learning, such as the FCAT, to determine teacher, school, and school district statistical distributions, which shall be determined using available data from the FCAT, and other data collection as deemed appropriate by the Department of Education, to measure the differences in student prior year achievement compared to the current year achievement for the purposes of accountability and recognition.
- (b) The statistical system shall provide the best estimates of teacher, school, and school district effects on student progress. The approach used by the department shall be approved by the commissioner before implementation.
- (c) The annual testing program shall be administered to provide for valid statewide comparisons of learning gains to be made for purposes of accountability and recognition. The 198529

commissioner shall establish a schedule for the administration of the statewide assessments. In establishing such schedule, the commissioner is charged with the duty to accomplish the latest possible administration of the statewide assessments and the earliest possible provision of the results to the school districts feasible within available technology and specific appropriation. District school boards shall not establish school calendars that jeopardize or limit the valid testing and comparison of student learning gains.

- (8) (7) LOCAL ASSESSMENTS.--Measurement of the learning gains of students in all subjects and grade levels other than subjects and grade levels required for the state student achievement testing program is the responsibility of the school districts.
 - (9) (8) APPLICABILITY OF TESTING STANDARDS.--
- (a) If the Commissioner of Education revises a statewide assessment and the revisions require the State Board of Education to modify the assessment's proficiency levels or modify the passing scores required for a standard high school diploma, until the state board adopts the modifications by rule, the commissioner shall use calculations for scoring the assessment which adjust student scores on the revised assessment for statistical equivalence to student scores on the former assessment.
- (b) A student must attain meet the passing scores on the statewide assessment required testing requirements for a standard high school diploma which are graduation that were in

effect at the time the student <u>enters</u> entered 9th grade 9 if, provided the student's enrollment is was continuous.

Adjunct certificateholders should be used as a strategy to reduce the teacher shortage; thus, adjunct certificateholders should supplement a school's instructional staff, not supplant it. Each school principal shall assign an experienced peer mentor to assist the adjunct teaching certificateholder during the certificateholder's first year of teaching, and an adjunct certificateholder may participate in a district's new teacher training program. District school boards shall provide the adjunct teaching certificateholder an orientation in classroom management prior to assigning the certificateholder to a school. 198529

Each adjunct teaching certificate is valid for 5 school years and is renewable if the applicant has received satisfactory performance evaluations during each year of teaching under adjunct teaching certification.
