Section 2. Paragraph (b) of subsection (1) of section 381.0072, Florida Statutes, is amended to read:

17 381.0072 Food service protection.-It shall be the duty of 18 the Department of Health to adopt and enforce sanitation rules 19 consistent with law to ensure the protection of the public from 20 food-borne illness. These rules shall provide the standards and 21 requirements for the storage, preparation, serving, or display 22 of food in food service establishments as defined in this 23 section and which are not permitted or licensed under chapter 24 500 or chapter 509.

25 (1) DEFINITIONS.-As used in this section, the term: 26 (b) "Food service establishment" means any facility, as 27 described in this paragraph, where food is prepared and intended 28 for individual portion service, and includes the site at which 29 individual portions are provided. The term includes any such 30 facility regardless of whether consumption is on or off the 31 premises and regardless of whether there is a charge for the 32 food. The term includes detention facilities, child care 33 facilities, schools, institutions, civic or fraternal 34 organizations, bars and lounges and facilities used at temporary food events, mobile food units, and vending machines at any 35 36 facility regulated under this section. The term does not include 37 private homes where food is prepared or served for individual 38 family consumption; nor does the term include churches, 39 synagogues, or other not-for-profit religious organizations as 40 long as these organizations serve only their members and quests 41 and do not advertise food or drink for public consumption, or
