Dear Interim Secretary Roberts:

By the authority vested in me as Governor of Florida, under the provisions of Article III, Section 8, of the Constitution of Florida, I do hereby withhold my approval of portions of House Bill 5001, enacted during the 112th Regular Session of the Legislature, since Statehood in 1845, convened under the Constitution of 1968, and entitled:

An act making appropriations; providing moneys for the annual period beginning July 1, 2010, and ending June 30, 2011, to pay salaries, and other expenses, capital outlay - buildings, and other improvements, and for other specified purposes of the various agencies of State government; providing an effective date.

The legislature has passed Florida's \$70.4 billion budget for Fiscal Year 2010-11, the largest budget in recent years. While economic recovery is on the horizon, General Revenue dollars are still scarce and spending has to be carefully prioritized to provide the most critical services to the citizens of our state. The majority of the budget provides funding for essential state services, protects our most vulnerable, keeps our citizens safe, and provides for the education of our children. For that I am grateful to our legislative leaders and commend their efforts.

My constitutional duty as the state's chief administrator for planning and budgeting for the state is to ensure the appropriate use of the people's money. Therefore, I directed my staff to provide a thorough review of each item in the budget. Through this process we have identified projects in the budget that were inserted late in the process; funded outside of established processes; and earmarked funds benefiting a select group or geographic region. While projects fitting this criteria were not vetoed comprehensively, they were reviewed exhaustively and approved if they served the most vulnerable, provided for job creation, or stimulated economic development.

There are several other items in the budget that I feel compelled to address.

First, with Florida's economy teetering on recovery, it is important that government act responsibly and take positive steps in favor of economic activity and higher employment. The legislature's decision to sweep the State Transportation Trust Fund tips the balance by eliminating transportation projects and removing jobs from the market. Further, the legislature chose to link this sweep to funding for the Florida Education Finance Program (FEFP). We should not have to choose between jobs for Floridians or funding for our children's education. Therefore I have decided to veto proviso that made funding for the Florida Education Finance Program (FEFP) contingent upon the transfer of funds from the State Transportation Trust Fund.

Second, I am concerned about prohibiting universities from conducting human embryonic stem cell research. The benefits of human embryonic stem cell research will allow researchers to understand the growth, development and differentiation of cells into several specialized cell types. This can lead to a better understanding of genetic diseases and has the potential for the development, testing of new therapies and medications that can help thousands of Floridians. In addition, other states have invested millions of dollars into human embryonic stem cell research because their state governments allow them to do this type of research. As a result, these states are seeing more research and development investment from national corporations and start-ups. Florida must diversify its economy and help its people. For this reason, I veto proviso that prohibits funds from supporting human embryonic stem cell research in our universities.

Third, the decision by the legislature to implement a recurring methodology for reducing nursing home reimbursement rates to achieve a reduction of \$199.4 million is of great concern to me. Over the past two fiscal years, nursing home reimbursement rates have been reduced. This additional rate reduction has the potential to create an access problem to long term care for Medicaid recipients. Nursing homes which serve a large percentage of Medicaid patients are at the greatest risk of closing their doors and going out of business. Consequently, I decided to veto proviso that would have reduced nursing home rates.

Last, I am also concerned about rate reductions that affect providers that serve Florida's most vulnerable citizens. Providers that serve the needs of the developmentally disabled have been subject to numerous rate reductions in the past few years. This additional reduction in the Fiscal Year 2010-11 General Appropriations Act of 2.5 percent places many of these services needed by the developmentally disabled at risk and many providers will have to shut down operations and close their doors. I am concerned about leaving the developmentally disabled population without a robust service delivery system to meet their needs and provide the specialty care they need. For these reasons, I am also vetoing proviso related to the 2.5 percent provider rate reductions.

I do hereby withhold my approval of the following line items in the 2010-11 General Appropriations Act:

Should the Agency for Health Care Administration be unable to use the full amount of these designated funds, remaining funds may be used secondarily for payments to Shands Teaching Hospital to continue the original purpose of providing health care services to indigent patients through Shands Healthcare System."

Specific Appropriation 219
Pages 69 and 70 - A portion of proviso language

"Funds in Specific Appropriation 219 reflect a reduction of \$76,690,037 from the General Revenue Fund and \$122,712,036 from the Medical Care Trust Fund as a result of modifying the reimbursement for nursing home rates. The agency shall implement a recurring methodology in the Title XIX Nursing Home Reimbursement Plan to reduce nursing home rates to achieve this reduction. In establishing rates through the normal process, prior to including this reduction, if the unit cost is equal to or less than the unit cost used in establishing the budget, then no additional reduction in rates is necessary. In establishing rates through the normal process, prior to including this reduction, if the unit cost is greater than the unit cost used in establishing the budget, then rates shall be reduced by an amount required to achieve this reduction, but shall not be reduced below the unit cost used in establishing the budget."

Specific Appropriation 242
Pages 72 and 73 - A portion of proviso language

"Funds in Specific Appropriation 242 reflect a reduction of \$6,465,891 from the General Revenue Fund and \$10,346,098 from the Operations and Maintenance Trust Fund as a result of reducing provider rates by 2.5 percent, effective July 1, 2010. Personal Care Assistance, transportation, waiver support coordination, durable medical equipment, consumable medical supplies, and environmental and home accessibility services are specifically excluded from this reduction target. The agency shall amend provider contracts, cost plans and rules as necessary to achieve this recurring reduction."

The Department of Children and Family Services shall use no more than 5 percent of the funds appropriated for this program to contract with a Florida public college or university to establish a process for evaluating the programs receiving grants through these appropriations. Evaluation criteria shall be based on best practices and program outcomes."

The funds in Specific Appropriation 185, shall be primarily designated for transfer to the Agency for Health Care Administration's Grants and Donations Trust Fund for use in the Medicaid or Low Income Pool programs. Of these funds, up to \$3,820,670 may be used in the Low Income Pool program or as funding to buy back the Medicaid inpatient and outpatient trend adjustments applied to Shands Healthcare Systems' individual hospital rates and other Medicaid reductions to their rates up to the actual Medicaid inpatient and outpatient costs. The transfer of the funds from the Low Income Pool program is contingent upon another local government or healthcare taxing district providing an equivalent amount of funds to be used in the Low Income Pool program. Should the Agency for Health Care Administration be unable to use the full amount of these designated funds, remaining funds may be used secondarily for payments to Shands Teaching Hospital to continue the original purpose of providing health care services to indigent patients through Shands Healthcare System."
