An act relating to interscholastic sports; providing a short title; amending s. 1006.15, F.S.; revising the criteria under which a charter school student may participate in interscholastic extracurricular activities of a public school; providing for certain private school students to participate in interscholastic sports at a public school under certain conditions; providing criteria; providing for a public school student to participate in interscholastic sports at another public school; providing criteria; providing an effective date.

Be It Enacted by the Legislature of the State of Florida:

- This act may be cited as "Erin's Law." Section 1.
- Section 2. Paragraph (d) of subsection (3) of section 1006.15, Florida Statutes, is amended, and paragraphs (e) and (f) are added to that subsection, to read:
- 1006.15 Student standards for participation in interscholastic extracurricular student activities; regulation .--(3)
- An individual charter school student pursuant to s. (d) 1002.33 is eligible to participate at the public school to which the student would be assigned according to district school board attendance area policies or which the student could choose to attend, pursuant to district or interdistrict controlled openenrollment provisions, in any interscholastic extracurricular activity of that school, unless such activity is provided by the student's charter school, if the following conditions are met:

1. The charter school student must meet the requirements of the charter school education program as determined by the charter school governing board.

- 2. During the period of participation at a school, the charter school student must demonstrate educational progress by maintaining the grade point average required by this section and passing each class for which he or she is enrolled as required in paragraph (b).
- 3. The charter school student must meet the same residency requirements as other students in the school at which he or she participates.
- 4. The charter school student must meet the same standards of acceptance, behavior, and performance that are required of other students in extracurricular activities.
- 5. The charter school student must register with the school his or her intent to participate in interscholastic extracurricular activities as a representative of the school before the beginning date of the season for the activity in which he or she wishes to participate. A charter school student must be able to participate in curricular activities if that is a requirement for an extracurricular activity.
- 6. A student who transfers from a charter school program to a traditional public school before or during the first grading period of the school year is academically eligible to participate in interscholastic extracurricular activities during the first grading period if the student has a successful evaluation from the previous school year, pursuant to subparagraph 2.
- 7. Any public school or private school student who has been unable to maintain academic eligibility for participation in

interscholastic extracurricular activities is ineligible to participate in such activities as a charter school student until the student has successfully completed one grading period in a charter school pursuant to subparagraph 2. to become eligible to participate as a charter school student.

- (e) A private school student is eligible to participate in interscholastic sports at the public school to which the student would be assigned according to the district school board's attendance area policies or at a public school that the student could choose to attend under district or interdistrict controlled open enrollment provisions if all of the following conditions are met:
- 1. The private school student meets the requirements of the private school program pursuant to s. 1002.42.
- 2. The private school in which the student is enrolled does not offer the interscholastic sports in which the student would participate at the public school.
- 3. During the period of participation at the public school, the private school student demonstrates educational progress by maintaining the grade point average required by this section and passing each class for which he or she is enrolled in the private school program as confirmed by a transcript from the private school. If the private school student is unable to maintain academic eligibility for participating in interscholastic sports, the student is ineligible to participate in such activities until he or she successfully completes one grading period in all subjects taken in the private school program.
- 4. The private school student meets the same residency requirements as other students in the school at which he or she

participates.

5. The private school student meets the same standards of acceptance, behavior, and performance as required of other students participating in interscholastic sports at the public school.

- 6. The private school student registers with the public school his or her intent to participate in interscholastic sports as a representative of the school before the beginning date of the season for the activity in which he or she wishes to participate; however, the private school student must be able to participate in curricular activities if that is a requirement for interscholastic sports. A student who transfers from a private school program to a public school before or during the first grading period of the school year is academically eligible to participate in interscholastic sports during the first grading period if the student meets the requirements of subparagraph 3. from the previous school year.
- 7. The private school in which the student is enrolled provides an affidavit to the public school which states that the private school:
- <u>a. Does not offer the interscholastic sports in which the</u> student would participate at the public school; and
- b. Did not offer the interscholastic sports in which the student would participate in during the prior academic year.
- (f) A public school student is eligible to participate in interscholastic sports at another public school to which the student would be assigned according to the district school board's attendance area policies or at a public school that the student could choose to attend under district controlled open

enrollment provisions if all of the following conditions are met:

- 1. The public school in which the student is enrolled does not offer the interscholastic sports in which the student would participate at the public school.
- 2. During the period of participation at the school, the student demonstrates educational progress as required in paragraph (a).
- 3. The public school in which the student is enrolled is in the same school district as that in which the student intends to participate in the interscholastic sports under this section.
- 4. The student meets the same standards of acceptance, behavior, and performance as required of other students in interscholastic sports.
- 5. The student registers with the school his or her intent to participate in interscholastic sports as a representative of the school before the beginning date of the season for the activity in which he or she wishes to participate. A student must be able to participate in curricular activities if that is a requirement for interscholastic sports.
- 6. A student who transfers from the school in which he or she is enrolled to another public school before or during the first grading period of the school year is academically eligible to participate in interscholastic sports during the first grading period if the student has a successful evaluation from the previous school year pursuant to subparagraph 2.
- 7. Any public school student who has been unable to maintain academic eligibility for participation in interscholastic sports is ineligible to participate in such activities until the student has successfully completed one
