Demonstrate the inflow abatement program can reduce rainwater inflow into sanitary sewer collection systems by up to eight percent (8%) or ten million gallons per day (10 MGD) during a 7-inch 24-hour rainfall. The program will consist of smoke testing aging sewer pipes for leaks, retrofit lateral cleanouts with removable plugs, seal manhole chimney leaks and install manhole rain dishes.
