The Town leveraged community support and received \$300,000 through the FY2015 legislative appropriations process and \$125,000 through the FY2016-17 South Florida Water Management District (SFWMD) Cooperative Funding Program (CFP) Stormwater Management Grant to assist in funding the project. In 2015, the Town Council unanimously passed Resolution No. 15-1333 adopting the 2015-2025 Strategic Plan and authorizing the Town Manager to take all actions necessary to implement its policies and goals.
