The Town held a Citizen and Council Session to gain community input on enhancing Town services. The community identified the clean-up of canals as a service area in need of improvement. The Town leveraged community support and received \$1 million through the FY2014 legislative appropriations process which completed the geotechnical and surveying of the entire 10,000 linear feet of the canal bank, and will construct approximately 3,000LF of the most unstable portions.

The canal bank stabilization survey and geotechnical have been completed for the entire project. A probable cost estimate was completed by an engineer consulting firm for the project. The estimated cost of this critical project is \$2.2 million. The cost is \$255 per linear feet.

The geotechnical and surveying of the entire 10,000LF of the canal bank was completed and construction of approximately 3,000LF of the most unstable portions of the bank is estimated for completion by June 2017. The Town desires to complete and stabilize the remaining 7,000LF of the canal.
