“Water Main Replacement – Phase 5” is on the heavily populated island of Venice. The new PVC pipelines will be relocated from the backyard easements and into the street right-of-way for better accessibility, safety and at a lower cost to the City for repair and maintenance. Dating back to the 1950s, cast iron pipe, 4 inch diameter or smaller, was used in the distribution of water and has reached its service life expectancy due to tuberculation making replacement an absolute necessity.
