Statistical reports of the current media lab show that it is well supported by the public. The Palm Beach County Library System currently houses one CreationStation digital media lab located at the Main Library in West Palm Beach. Within the first year of operation, 668 sessions were booked with a total use of 1350 hours by the public. Additionally, 82 classes were taught, 18 orientations were provided, and 18 Teen Times sessions were offered.
