The Interstate 75/State Road 47 interchange is geographically located in a distinguishing ecological location in that the Cannon Creek Sink is with 100 feet from the traffic flow of these two roadways. This project will provide connections to 30 existing businesses and 5 homes and will provide access to wastewater treatment for an additional 35 properties in Phase 1. The project would mitigate further impact of damaging nutrient levels (up to 64,600 LBS possible) within the Ichetucknee Basin.
