The design phase of a wastewater system in the Harbinwood Estates neighborhood, to be connected to the City of Tallahassee's central sewer system. The project will reduce nitrogen and fecal coliform discharges to nearby natural systems, including the Lake Jackson Aquatic Preserve. Converting wastewater treatment in the subdivision to advanced wastewater treatment will reduce the total nitrogen load by 8,000 pounds per year, contributing significantly to the protection of ecological resource.
