If unattended the erosion will impact established forest lands and erode away the trails and entrance to Morgan Park. A Restoration & Stabilization Plan has been established by Amec Foster Wheeler in coordination with Desoto County Parks /Rec. and the Charlotte Harbor Natural Estuary Program.
