Sudden Cardiac Arrest (SCA) kills more student athletes than any other cause (Meyer et al., 2012), stealing hundreds of young lives every year. It is also the number one cause of death on school property. Student athletes are at an even higher risk of dying than the general

population, despite the fact that they receive annual physical examinations as part of their athletic participation. Recent studies have shown the physical to be woefully inadequate in recognizing cardiac problems that cause
