The Federal Equipment Matching Grant program supplied federal funds for Florida public broadcasters. Grants were to be matched by the state, which it did for a number of years. Funds were used to replace obsolete equipment, so stations could successfully operate in a digital environment. In addition, funds could be used to purchase important equipment such as emergency generators. Affected stations had broad support within their listening and viewing areas for these initiatives.
