The North Indian River Lagoon Muck Dredging project will remove about 535,000 cubic yards of muck soils from within the North Indian River Lagoon system and associated tributaries. The project will reduce nutrient loading to the IRL system and is essential to protecting and restoring the health of the estuarine network.

To address serious water quality issues associated with muck sediment in the Indian River Lagoon, the Florida Legislature in the 2014-17 sessions directed a total of \$3.5 million to the Florida Institute of Technology Indian River Lagoon Research Institute to investigate the effects of muck and environmental muck dredging. A collaborative County and University effort developed multiple research studies at multiple sites to improve the prioritization and efficiency of muck management efforts.
