This project includes the installation of catch basins along SW 160th Avenue at the intersection of Griffin Road (State Road 818) to mitigate flooding and convey stormwater away from the respective roadway. The project was intentionally designed to include two (2) acres of created wetlands along the park waterway to improve water quality from the surrounding storm water run-off. The project will also significantly reduce flood staging within SW 160th Avenue during heavy rainfall events.
