This project will replace approximately 1,000 linear feet of seawall along Isle of Palms Drive. This project will fund the design, permitting, and construction to replace the existing seawall. Some portions of the seawall appear to be bulging towards the canal, with multiple cracks and fractures present. The area has been known for floods, leaving the entire seawall underwater during heavy showers and storms.
