The County's goal is to construct this project concurrently with the Indian Springs Phase 1 Sewer Extension which has already been funded by FDEP Springs Protection Funds in order to eliminate individual septic systems and is expected to begin construction in 2017. Central water will allow a means for metering water & sewer usage
