The two projects are: Lake Asher Restoration, which will remove excessive aquatic vegetation and associated sediments; and, Alton Drive Pond Retrofit, which will reroute untreated stormwater into an existing retention pond, thus improving water quality in the downstream waterbodies and the Wekiva River.
