Shelters typically serve to house people during and after a dangerous storm event. Following severe weather experience in the region, we learned that much of the community can shelter in place, but need access to facilities to get water, ice, cool down, and charge electronic equipment. Geographically dispersed community comfort stations could serve this purpose, ten locations (mixture of libraries and community centers) throughout Tallahassee and Leon County have been identified for such use.
