This project will improve water quality in the Loxahatchee River. This project will result in 181 homes abandoning their existing septic system and connecting to the regional sanitary sewer system. These 181 homes generate nearly 15 million gallons of wastewater per year. 100% of these grant funds (\$3,000 per home) will be disbursed to affected property owners to offset their actual costs associated with abandoning their septic system and connecting to the sewer system.
