Nationally renowned homelessness expert, Dr. Robert Marbut, was hired to develop recommendations to reduce street-level homelessness in Daytona Beach area. He submitted a comprehensive study of Volusia County's homeless population in 2014 and an Action and Business Plan for First Step Shelter, submitted in 2015. The City of Daytona Beach and other municipalities, as well Volusia County subsequently agreed to proceed with the First Step Shelter, a 24/7 comprehensive homeless services center.
